THEME

Training and improvement of competences on: European Programs and Design of Projects Grants in Europe (for citizens that by their position in public institutions or NGOs in the social field can multiply participation in Europe of people in vulnerable situations)

Project Objectives

- Contribute to an increased understanding of the EU by citizens and to improve conditions for civic and democratic participation at Union level (objectives and priorities of the programme Europe for Citizens in 2015)
- Improving competence and knowledge of European Programs in the social field and Citizen Participation for public bodies and local NGOs
- Improving competence and knowledge on design of European Projects in the social field and Citizen Participation for public bodies and local NGOs
- Share knowledge and experiences acquired by the different partners in this subject
- Creating Synergies for future European projects in the social field and citizen participation
- Development of an international network of cooperation in the social field and citizen participation

Our goal is: each partner will gain skills and knowledge how to develop projects within European Programs that improve European Participation of peoples in vulnerable situation

Planned activities

Training Days (Three International Events) in Social European Programs (EaSI PROGRESS Axis Social Innovation, PROGRESS, Europe for Citizens, Erasmus + Key Action 2 and DG Justice: DAPHNE and Child Rights in Judicial Processing).

During each visit, we work with one part of a project process.

The topics are: First, all about the selection of the programme, call proposal, partner's selection and design of the application form; Second, all about the management of the project, (budget, "follow-up", etc.) and Third, all about evaluation and final report of the commission.

With the International Events we will make a **handbook** with all information generated and **videos tutorial**



The countries that cannot host one of International Event, will hold a **National Training Day**. They must use the materials of the project. The aims is to disseminate the new knowledge among their City Halls and NGOs to regional level.... and these National Training Day (3- 4 in total depending on the number of countries) will serve as proof of the effectiveness of the materials. These National Training Days will have also several Teachers offered by others partner countries with expertise in the subject.

Role of the partner organisation in the project

During the phase of program preparation partners will designate their participants (3-5 persons depending on the number of the cities participating in the project), representatives of localgovernment bodies (Social Welfare) and non-governmental organisations in the social field and Citizen Participation

The schedule of activities will be prepared jointly

The First Training Day will be held in Palma de Mallorca – the leader of the project

The project kick-off meeting will be held in Palma de Mallorca the day before the first international event: only one person per member country who will act as coordinator for all partners in your country. All International and National Events will be organized jointly between these coordinators and the leader, Palma de Mallorca

The second and third international event will be held in countries that have the lowest costs of accommodation and travel

Participate in the production of materials for dissemination (handbook and video tutorials)

Participate in the dissemination strategy at regional or international level

Participate in project's evaluation

Professionals (proposed by the partners with demonstrated expertise in European Programs or in design of European social projects) that could participate as *volunteer teacher* in the National Training Day Events will be welcome
